Your Excellency,

We crave audience of you at the earliest date practicable for the purpose of stating to Your Excellency in person:

1. That we have read in the newspapers of the Colony with grave concern that the Honourable L.A.F.O'Reilly, K.C., a Rominated Member of the Legislative Council, will move the Council at its next meeting that in the opinion of Council it is desirable that jurisdiction should be conferred upon the Supreme Court of the Colony to decree the dissolution of marriage.
2. That we have been shown statements in relation to this matter signed by the Colonial Secretary that indicate that the Government were not aware of this threatened renewal of the attack upon the sanctity of marriage up to the 1st December last. (Copies of these statements are attached).
3. That we also have before us a copy of a letter written by Your Excellency to His Grace the Archbishop of Port-of-Spain on the 28th May last, in which Your Excellency assured His Grace that before you decided what attitude the Government would adopt in the view of the Pope and of the Catholic Church in this Colony.

4. That we have before us a copy of "Hansard" regarding the debate in Council of the 31st May 1926, in which the Colonial Secretary as spokesman for the Government is reported as having said:

"Until public opinion had had time to thoroughly discuss the subject, to formulate and settle, or clarify itself and arrive at considered conclusions as to the effects of such a change on all interests in the Community, the Government would not be willing to pledge itself in the matter. For this reason and without expressing any opinion on the merits or demerits of the proposal, the vote of the Government Bench on this occasion and at this stage would be against the motion".

5. That in the Year 1926 numerous signed petitions were presented to the Governor by Catholics and Members of the Church of England throughout the Colony protesting against the introduction of a Divorce Law in the Colony.

6. That there is no evidence that public opinion demands the introduction of Divorce here, but, rather, that the circumstance that the Heads in this Colony of the Roman Catholic Church and of the Church of England and of the Muslim Church and representatives of the Hindu Church in the Colony, stand united today in one common solemn protest against the introduction of Divorce Law ought to afford Your Excellency most striking proof that the vast majority of the people in this Colony wish that the Government should not proceed.

It be brought to the notice of the Executive Council and of the Legislative Council and of the Right Honourable the Secretary of State for the Colonies forthwith that we pray that the Government do not give assentance to this profound change of the law of the land which is disapproved by the great majority of the people of the Colony.

We, the undersigned, are Pundits among the Hindus in this Colony. There is no one Pundit in Trinidad who takes precedence over all others, and therefore the Hindu Community is unable to express itself through any one person.

The Hindu religion does not permit divorce, we have read the letter signed by representatives of the Roman Catholic Church, the Church of England and the Muslim Church and we agree with the statements made in it, and we join in praying that the Government do not give countenance to the introduction of a Divorce Law in this Colony; and we also join in asking that our protest against the introduction of Divorce in Trinidad be brought to the notice of the Executive Council, the Legislative Council and the Right Honourable the Secretary of State for the Colonies.

That the said Protest, 28th March, 1931, was presented to
His Excellency Sir Alfred Claude Hollis, K.C.M.G., C.M.G., C.B.E.,
Governor and Commander-in-Chief in and over the Colony of Trinidad and Tobago and its Dependencies,
Vice Admiral thereof, etc., etc.,

May it please Your Excellency,

At a meeting of the Tackviyatul Islamic Association of Trinidad, held on Tuesday 28th March, 1931, I was directed to bring to Your Excellency's notice the following:

1. That the Tackviyatul Islamic Association of Trinidad represents the entire Muslim Community numbering over Seventeen thousand (17,000).
2. That their attention has been drawn to a Protest made against the introduction of a Divorce Law in the Colony, at a Mass Meeting held at the Queen's Park Savannah on Sunday 22nd March, 1931.
3. That the said Protest is to be submitted to the Secretary of States for the Colonies.
4. That it is alleged, that the Muslims, among other denominations also took part in that Protest.
5. That the Tackviyatul Islamic Association of Trinidad which represents the entire Muslim Community, declare that no Muslim took any active or official part in that Protest, and that the only person who presented the Protest to the Secretary of States for the Colonies, and this fact can be verified by the speeches made at

the said Mass Meeting.

6. That the said Tasvkiyatul Islamic Association of Trinidad on behalf of the Muslim Community of the Colony beg to entirely disassociate themselves from that Protest.
7. That the Kazi, Haji Mukhammadin Wesh also take the opportunity, herewith, to officially withdraw his name from a Divorce Protest which he was misled to sign on 26th February, 1931.
8. I am further directed to ask Your Excellency whether the Divorce Bill, if passed into law in this Colony, will in any way interfere or deprive Muslims from the Privileges which they possess under the Immigration Ordinance Cap. 245.
9. That may it please Your Excellency, the said Tasvkiyatul Islamic Association of Trinidad beg Your Excellency to submit a copy of this letter to the Secretary of State for the Colonies.
